
- Miloda is the only public sector tertiary level educational center in Sri Lanka that has specialized for Financial Studies training.

















### **National University of Singapore (NUS)**





#### Marketing Initiatives

With the intention of creating awareness, increasing revenue and market share, AFS has started to implement its marketing/sales strategies step by step and following initiatives have taken;

#### 1. Client Visits

Target market of AFS is staff grade officers at Ministry of Finance. In order to generate more revenue AFS need to reach following clients;

- All Ministries and its departments
- Government Departments
- Statutory bodies
- Government Banks
- Divisional Secretaries
- Professional Bodies
- Government institutes

#### 2. Direct Mail

AFS has designed a request letter to get nominations for the scheduled programs and has sent that letter with the application and the 3 months bulletin to its clients via direct mail.

For scheduled programs AFS has targeted minimum 30 participants for each program. There for application were categorized based on the programs selected by clients and held the respective programs were held once AFS received more than 30 applications per one program.

#### 3. Online registration for CPPP Course

AFS has signed an MOU with the World Bank for a Joint Certification Program in Public Procurement. CPPP is an important foundation certification for all who want to be involved in the procurement field.

This certification can be completed via online and participants will have to get register through the <a href="https://www.afs.gov.lk">www.afs.gov.lk</a> which helps to publicize the AFS and its website.

It is observed that 114 no of participants have registered and 9 participants completed and Diploma course will be launched once there is a significant completion. Diploma courses will be held at Miloda and will be charge a course fee for the Diploma in Public Procurement.

### **FUTURE DEVELOPMENTS OF MILODA**

#### Budget 2017

Budget 2017 was prepared to monitor the financial impact of marketing and operational decisions of AFS. It includes Rs. 120m budgeted revenue to be achieved in the year 2017, maintenance budget, IT expense budget, Human Resources Budget, Transport Budget etc. This budget will facilitates to adjust the organizational goals going forward.

#### - Program Development

In order to accomplish the target of Rs. 120m in 2017, Currently AFS is in the process of developing new courses for a period of 3 months, 6 months, 1 year and as well as the training program schedule for the year 2018.

#### - Operation of Miloda AFS restaurant

The restaurant at Miloda Academy of Financial Studies has never been operated, and it has been idling ever since the academy was opened. The entire infrastructure necessary for a high quality restaurant is available and they are in ready to use condition. Seating is available for over 100 people at one sitting. The facility is located on the ground floor of the building and it has easy access. With the expansion of operations at the academy, there are programmes both during weekdays and weekends. Catering is frequently outsourced and the catering bill consumes a sizable amount in the programme budget. This affects considerably on the net profit earned by the academy. In addition, since the restaurant is fully equipped and ready to operate, it can be given on rent to a suitable service provider, and catering services can be obtained at a subsidized rate for internal training programmes.

In order to find out suitable service provider for the restaurant, AFS needs to undertake the government tender procedure and the restaurant tender must be done according to the National Competitive Bidding procedure. Currently bidding document has been prepared and in the process of getting the approval and recommendation from technical evaluation committee and the procurement committee. Once it is completed, AFS can call sealed tenders.

#### - Setting up a Library

Library is a store house which has a vast collection of academic books. In order to uplift the quality of the training institute and to build up a knowledge driven set of participants who visits AFS for training programs, it has decided to open up a Library in future.
